**WHEREAS**, Hartstene Pointe Water - Sewer District held a hearing on proposed 2010 budget and heard testimony at said hearing; and

**WHEREAS**, Hartstene Pointe Water - Sewer District reviewed budget hearing testimony; and

**WHEREAS**, District Commissioners determined that proposed 2010 budget included expenditure limitation of \$288,288.00 to allow for the prudent operation of the systems, and


**WHEREAS**, Estimated revenues of \$288,288.00 were adequate to fund expenditures;

**ADOPTED, by the District's Board of Commissioners at a regular scheduled meeting on November 5, 2009.**


